1. NAME

- The name of the society shall be 'SHREE NIADER SINGH YADAV MEMORIAL CHARITABLE TRUST. DELHI.
- 2. REGISTERED OFFICE
- The registered office of the society shall remain in Union Territory of Delhi, presently it is at 99, Main Chewk, Samaipur, Delhi-42.
- 3. AIMS & OBJECTS
- : To work for the education upliftment of the general public.
  - b) To provide better education on the modern lines to the deserving students.
  - c) To establish, manage and to Control Educational Institution for the above objects.
  - d) To takeup the matter with the authorities for the alletment of land, for the construction of educational institution in different parts of Union Territory of Delhi.
  - e) To do all such that things which may appear beneficial for the educational upliftment of the general public.
  - f) To work for the eradication of illeteracy in the general public.
- 4. ANCILITARY OBJECT

No member of the society shall have any personnal claim on any moveable or immovable properties all the society/association/make any profit, whatsoever by virtue of this membership.

# RULES & REGULATIONS 'SHREE NIADER SINGH YADAV MEMORIAL CHARITABLE TRUST. DELHI

1. NAME : The name of the society shall be SHREE NIADER SINGH YADAV MEMORIAL CHARITABLE TURST. DELHI.

- 2. MEMBERSHIP

  Subject to the approval of governing body any person may become a member of the society provided he/she believes in the aims and objects of the society.
- 3. SUBSCRIPTION : The rate of yearly subscription for all the members shall be Rs.251/- and admission fee Rs.5100/-.
- 4. REFUSAL:

  The governing body of the society may refuse any person for the membership, provided reasons for refusal shall be communicated to the person concerned.
- EXPULSION: The governing body of the society may expel any member from the society on the following grounds:-

(111 May 1911)

- i) If the member fails to pay the timely subscription continously for three months from the due date of paying the subscription.
  - If the member works against the alms and objects of the society.
  - If the member fails to attend three meetings of governing body.
- iv) If the member tenders his/her resignation.

The reasons of expulsion shall be communicated to every member. Every such expelled member shall have a right to appeal before the general body which may or may not be accepted.

## 6. GENERAL BODY

- There shall be a general body of the society consisting of all the members. The meetings of the general body shall be held after every one year with 1/3 quorum. No quorum shall be required in the adjourned meeting. An emergent meeting of the general body may also be summoned on the written request of 1/2 members. Following business shall be transacted in these meetings:
- To prepare annual programmes and policies.
- 1i) To pass annual budget of the society.
- other matters and issues which are directly or indirectly related to the affairs of the

To appoint an auditor who will annually inspect the accounts of the society's funds.

### 7. GOVERNING BODY

- There shall be a governing body of the society to look after and to manage the day to day affairs of the society. It shall consist of minimum 7 and maximum 15 members including the office bearers. The meetings of the governing body shall be held after every six months with 1/3 quorum. No quorum shall be required in the adjourned meeting. An emergent meeting of the governing body may also be summened on the written request of 1/2 members. The following business shall be transacted in these meetings :-
  - To take necessary steps for the implemena) tation of all the programmes and policies drawn by the general body.
  - To pass the necessary expenditure to b) meet the day to day requirements of the society.
  - c) To take all such other legal steps which may appear beneficial for the smooth and better management of the society.

To open branches in different part of India.

To open manage and to control branches at the state and district levels.

The following is the present structure of the governing body:-

- 1. Chairman
- 2. Secretary
- 3. Treasurer
- 4. Members not more

than 12

## 8. OFFICE BEARERS AND THEIR DUTIES

### (a) Chairman

- He shall preside over all the meetings of general body and governing body.
- ii) In case of equality of votes in any meeting, he shall tender his casting vote.
- iii) He shall supervise work of other office bearers from time to time.
- iv) He shall keep all types of record of the society including the register of members containing there in the names, addresses and other brief particulars.
- v) He shall undertake all types of cerrespondences on behalf of the society.
- vi) He shall work under the supervision and control of Chairman.

### (b) SECRETARY

He shall represent the society in all public and private offices.

He shall convene the meetings of general body, governing body and he shall also inform every member regarding time, date and place of the meeting through a ten days earlier written notice.

(c) TREASURER

She/He shall collect subscriptions, gifts, grants-in-aid and donations from the members and general public and she shall also be responsible for keeping and maintenance of a true and correct accounts of the society's funds.

9. FINANCIAL YEAR

The financial year of the society shall be from 1st April to 31st March every year.

10. SOURCE OF INCOME

Saving from Running & Educational
Institution Subscriptions, Donations,
Grants-in-aid and gifts from the members
and general public shall be the source of
income of the society.

11. BANK A/C OPERATION :

The funds of the society shall be kept in a Scheduled Bank. The Bank Account shall be operated by following two out of three office bearers:-

(i) President (ii) Secretary (iii) Treasurer with their joint signatures.

12. ELECTION

The governing body of the society shall be elected for a term of three years in the general body meeting. The secret ballet system shall be the mode of election.

13. ANNUAL LIST

Every year a list of governing body office bearers and members shall be filed in the office of Registrar of Societies, Delhi as required u/s 4 of S.R.Act of 1860.

- LEGAL PROCEEDINGS 14.
- The society may sue or be sued in the name of its President as required u/s 6 of S.R.Act of 1860.

15. AMENDMENT Any amendment in the memorandum or rules of this society shall be carried out in accordance with procedure laid down u/s 12 and 12-A of S.R.Act of 1860.

DISSOLUTION

I This society may be dissolved in accordance with procedure laid down u/s 13 and 14 of S.R.Act of 1860.

All the provisions of S.R.Act of 1860 (Punjab Amendment Act of 1957) as extended to Union Territory of Delhi shall apply to this society.
